4. FIRST AID MEASURES

Skin contact	Wash immediately with water for at least 20 minutes. Remove contaminated clothing. If skin irritation persists call a physician.
Eye contact	Irrigate with copious supply of clean water. Obtain medical attention if any discomfort continues.
Ingestion	Do not swallow, rinse mouth with water. If swallowed, drink water. Obtain immediate medical attention. Do not induce vomiting.
Inhalation	Remove to fresh air, rest and keep warm.

5. FIRE FIGHTING MEASURES

This material is non flammable. Extinguish surrounding fires with Carbon Dioxide, Foam, Dry Powder, Water Fog or Spray as appropriate. Cool containers with water spray.

Spillage
